**CERTIFICATE U/S. 12AA(1) OF THE INCOME TAX ACT, 1961**

The above Trust/Institution/Society which is created/established on 02-12-2006 has filed an application for registration u/s. 12AA(1) of the Income tax Act, 1961 in the prescribed form on 17-06-2009. **Registration u/s. 12AA(1) of the I.T. Act is granted w.e.f. 17-06-2009.**

The application has been entered at F. No. 13/CIT-GLB/2009-10 in the register of applications u/s. 12A(a) of the Income tax Act, 1961 maintained in this office.

The registration u/s. 12AA of the IT Act, 1961 does not automatically exempt the income of the Trust/Institution/Society. Also the registration u/s. 12AA of the IT Act, 1961 does not confirm any exemption or deduction u/s 80G of the IT Act, 1961 to the donors. Separate application in prescribed form has to be filed by the Trust/Institution/Society before the respective Commissioner of Income tax, who is having jurisdiction, in order to seek benefit u/s. 80G of the IT Act, 1961.

Further, this certificate cannot be used as a basis for claiming non deduction of tax at source in respect of investments etc., relating to the Trust/Institution/Society. Separate application in the prescribed forms have to be filed before the Assessing Officer in order to claim non deduction of tax at source.

7 The Assessing Officer is at liberty to determine the taxability of income of the Trust/Institution/Society with reference to Section 11,12 and 13 of the IT Act, 1961 and also to verify the genuineness of the activities of the Trust/Institution/Society.

The Trust/Institution/Society shall apply for PAN, if not already applied for and quote the PAN in all its communications.

The Trust/Institution/Society shall furnish a Return of Income every year within the time limit prescribed under the Act.
